## THE SCHEDULE OF APPROVAL

### 1. PRODUCT DESCRIPTION:

The HAMMAR Manual Remote Release System (MRRS) is intended to release liferafts from a distance by means of a manually operated vacuum pump. The system needs to be serviced and checked annually and in accordance with the manufacturer's instructions. The Hammar H20 Hydrostatic Remote Release Unit is of a disposable type and does not need to be periodically serviced, but shall need to be replaced every two years.

### 3. TEST REPORTS:

Approval based upon:

- Type tests carried out for type approval of HAMMAR H20 HRU for fitting float-free arrangement of liferaft.
- Further technical assessments made by the Department of Trade as per letter nr MS3/14/0869 dated 11/05/1993 and by the Swedish National Maritime Administration as per letter nr 21.11.9272854 dated 24/02/1993.

### 4. APPLICATION / LIMITATION:

#### **Other materials and/or components:**

- HAMMAR H20 Hydrostatic Remote Release Unit.
- Hand pump RRS (part nr HM-0301) as per drawing F3013-03.
- A 3 mm diameter stainless steel tubing (AISI 316) - part nr HM-0311.
- A 1 metre length flexible tubing in black Nylon 6.
- A U-console - part N° HM-0305, to be installed at the liferaft cradle.

#### **Application / Limitation:**

- To be used for remote release of inflatable liferafts.
- Since not submitted to the painter strain there is no limitation in respect to the liferaft capacity (the "Rope sling", which is part of the device was strength tested at 15 kN, liferaft for more than 25 persons)
- HAMMAR H20 Hydrostatic Remote Release Unit needs no annual service, maintenance or spare parts, but must be replaced after two years.

#### **On board installation / Maintenance requirements:**

- To be installed on board in accordance with requirements of Regulations stated on the front page of this certificate and Manufacturer's instructions
- It shall be provided with a simple system of recording the expiry date (month/year) at which the unit must be replaced
- If marked with more than a single expiry date (month/year), the unit will be invalid and must be replaced.
- To be supplied with installation instructions written in English language.

### 5. PRODUCTION SURVEY REQUIREMENTS:

To be manufactured, checked for quality and tested in accordance with the protocol approved by Bureau Veritas on the basis of Part 2 of IMO Resolution MSC.81 (70).

### 6. MARKING OF PRODUCT:

To be permanently marked on the Hydrostatic Remote Release Unit or identification plate securely attached to the unit, as follows:

- HAMMAR MRRS.
- Serial number.
- Expiry date.
- MCA (UK) approved.

**7. OTHERS:**

- This approval is given on the understanding that the Society reserves the right to require check tests to be carried out on the MRRS at any time and that CM HAMMAR AB, Sweden will accept the responsibility for informing shipbuilders or their subcontractors of the proper methods of use and general maintenance of the equipment and the conditions of this approval.

- This certificate supersedes Certificate of Type Approval N° 07495/B1 MCA issued by the Society on 17/09/2003.
